LANGKAWI SKY BRIDGE

The Langkawi Sky Bridge is a 125-meter-long curved pedestrian bridge located atop Gunung Mat Cincang. Suspended 660 meters above sea level, it offers panoramic views of the surrounding rainforest and the Andaman Sea. Accessible via the Langkawi Cable Car, the bridge provides a thrilling experience for visitors seeking breathtaking vistas.



LANGKAWI CABLE CAR (SKYCAR)

The Langkawi Cable Car, also known as SkyCar, transports visitors from the Oriental Village to the peak of Gunung Mat Cincang. The 15-minute ride spans 2.2 kilometers and offers stunning aerial views of waterfalls, dense forests, and the island's coastline. At the top, visitors can access viewing platforms and the Sky Bridge.



KILIM KARST GEOFOREST PARK

Kilim Karst Geoforest Park is a UNESCO-listed site featuring mangrove forests, limestone formations, and diverse wildlife. Visitors can explore the park via boat tours, witnessing caves, hidden lagoons, and a variety of flora and fauna, including monitor lizards and eagles.



UNDERWATER WORLD LANGKAWI

Located in Pantai Cenang, Underwater World Langkawi is one of Southeast Asia's largest marine and freshwater aquariums. It houses over 4,000 aquatic species, including sharks, stingrays, and turtles. A highlight is the 15-meter-long tunnel that provides a 360-degree view of marine life.



TELAGA TUJUH WATERFALLS (SEVEN WELLS)

Telaga Tujuh, or Seven Wells Waterfalls, is a series of seven natural pools connected by cascading waterfalls. Nestled within a lush rainforest, it's a popular spot for swimming and picnicking. Adventurous visitors can hike to the top for panoramic views and a refreshing dip.



DATARAN LANG (EAGLE SQUARE)

Dataran Lang, or Eagle Square, features a 12-meter-tall statue of a reddish-brown eagle poised for flight. Located in Kuah Town, it's one of Langkawi's most iconic landmarks, symbolizing the island's name, which is derived from the Malay word for eagle, "telang."



PARADISE 3D MUSEUM

The Paradise 3D Museum is the second-largest 3D art museum globally, featuring over 200 interactive artworks across nine themed zones. Visitors can pose with optical illusions and immersive paintings, making it a fun destination for families and art enthusiasts.



TAMAN LAGENDA (LEGEND PARK)

Taman Lagenda is a beautifully landscaped open-air park that brings Langkawi's myths and legends to life through 17 colorful sculptures. Visitors can learn about local folklore while strolling through gardens, making it both an educational and relaxing experience.



LANGKAWI WILDLIFE PARK

Langkawi Wildlife Park is an indoor facility housing over 60 species of animals and birds. Visitors can enjoy interactive experiences like feeding parrots, deer, and rabbits. The park's fully covered walkways make it a great destination regardless of weather conditions.

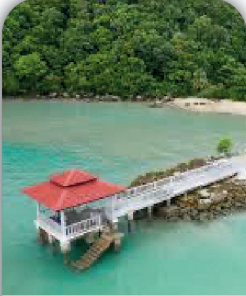


ORIENTAL VILLAGE

PULAU TUBA

Pulau Tuba is a hidden gem in Langkawi, Malaysia, offering a serene escape into traditional village life, natural beauty, and cultural heritage. Accessible via a 20-minute boat ride from Kuah Jetty, this tranquil island is perfect for travelers seeking an authentic and off-the-beaten-path experience.



CROCODILE ADVENTURELAND

Crocodile Adventure Land is considered to be the biggest crocodile farm in Malaysia. Locally known as Taman Buaya Langkawi, it is home to thousands of crocodiles from various species. Here, you can see the smallest dwarf crocodiles to the saltwater giants weighing up to 1 tonne.



COMPLEX CRAFT LANGKAWI

The Langkawi Craft Complex, established in 1996, is a cultural and heritage center in Langkawi, Malaysia, showcasing the country's rich artistic and cultural heritage. It features several museums, including the Marriage Customs Museum and the Heritage Museum, along with a Crafts Bazaar for purchasing traditional crafts.



MAHSURI TOMB AND MUSEUM

The legend of Mahsuri, a young woman who was unjustly accused of adultery and executed in the late 18th century. The site includes the traditional Malay tomb of Mahsuri, a museum with interactive exhibits, and scenic gardens. The legend of Mahsuri, including her supposed curse on Langkawi, is a significant part of the island's culture and heritage.



TOUR THE ISLANDS BY JET SKI

A Langkawi jet ski tour, particularly the Island Hopping tours, offers a thrilling way to explore the archipelago's 8 islands and surrounding waters. These tours allow you to navigate crystal-clear waters, explore hidden coves, and enjoy stunning views from a unique perspective.
